Title: CRCO ERP Implementation

**General:** 

EUROCONTROL\* is an intergovernmental organisation with 41 Member and 2 Comprehensive Agreement States. We are committed to building, together with our partners, a Single European Sky that will deliver the air traffic management (ATM) performance required for the twenty-first century and beyond.

Technical subject matter:

The objectives of the CRCO Financial Management System (CRCO Oracle ERP) project are the following:

- The principal objective is to integrate the debt collection, accounting and treasury of the Bilateral Agreements and of the Multilateral Agreement under a single Commercial Off-The-Shelf (COTS) software, which provides a higher degree of granularity in accounting data and reporting with real-time data. The idea is to stay as close as possible to the standard functionalities of the COTS.
- The capabilities of the current system must be maintained. It should be highlighted that the current systems already enable the CRCO to achieve excellent results (average recovery rate of 99,7% over the last ten years);
- An underlying objective is to rethink and streamline current financial management processes, as appropriate;
- The CRCO Financial Management system shall increase user-friendliness:
- CRCO Oracle ERP shall also provide advanced automation and agility, in order to better meet new requirements in the future;
- CRCO Oracle ERP will resolve the current obsolescence of CRCO applications.

The tenderer shall provide examples on maintenance and support work for existing clients and the associated template agreement(s).

The tenderer shall demonstrate:

- Ability to develop documentation in English and French, both on paper and online.

## PASS/FAIL TECHNICAL ASSESSMENT CRITERIA

The Tenderer shall provide an overall assessment on its ability and added-value for EUROCONTROL in the delivery and execution of the Project described in this CFT.

The Tenderer shall demonstrate staff capacity. The Tenderer, with any subcontractors included in the bid, has the necessary staff capacity to be able to carry out the project as envisaged by EUROCONTROL and within the defined period of time in the required quality, as described in Part 6.4 (Project Organisation).

The tenderer shall confirm whether it is compliant or not with Compliance Table in Appendix A4. In case of no compliance with any of those requirements, the tenderer will be declared non-compliant and will not be further assessed.

### SCORING TECHNICAL ASSESSMENT CRITERIA

The tenderer shall propose a robust and structured project planning and methodology to cover the objective of the contract.

The Tenderer shall provide the composition and size of the Contractor's project Team and Key Resources. Please refer to Part 6.4 (Project Organisation) where key profiles are described.

The Tenderer shall provide its exit plan to the support provider and exit plan at project end, covering part 2.3.3 (Implementation services).

The Tenderer shall present its global understanding of the conceptual design and main processes, as defined in Part 4,2 (Functional Requirements).

The Tenderer shall present its view on how to translate functional requirements into the technical implementation in Oracle ERP Cloud, as defined in Parts 4.2.1 (Accounting requirements), 4.2.2 (Collection requirements), 4.2.3 (Treasury requirements), 4.2.4 (reporting requirements).

The Tenderer shall present its understanding of the Masterdata and its view on which system should own which set of data, as defined in Part 4.2.5 (Master Data).

The Tenderer shall present its global understanding and view on the Architecture, Integration and Interfaces requirements, as defined in Part 4.3 (non-functional requirements).

The Tenderer should propose an Automated Testing strategy.

The Tenderer shall present its view on the Security requirements coverage.
